

# Terms and Conditions

## 1. TERMS

These terms and conditions, as well as any other policies on Stradigi AI's website (the "Website"), including, but not limited to, the Privacy Policy (collectively the "Terms") constitute a binding legal agreement between you ("you" or the "User") and Stradigi AI Inc., or any of its subsidiaries or affiliated companies ("Stradigi AI", "we" or "us") and govern the use of the Website.

*This paragraph does not apply to consumers of the Province of Quebec (Canada) to whom Quebec’s Consumer Protection Act (chapter p-40.1) applies.* You irrevocably agree and acknowledge the exclusive competence of courts under federal and provincial jurisdiction sitting in the judicial district of Montreal for any dispute which may arise in connection with the Terms or related thereto, elect domicile therein and waive any objection based on the lack of subject-matter jurisdiction or any claim based on the notion of *forum non conveniens*.

## 13. SEVERABILITY

Each provision of these Terms is separate and distinct and, if a provision of these Terms is held invalid, illegal or unenforceable, all other provisions will remain in full force and effect.

## 14. WAIVER

A failure to act or delay in acting by Stradigi AI with respect to a non-performance, or the non-exercise of a right under these Terms will not operate as a waiver of that

performance or of that right. The waiver of a right under these Terms by Stradigi AI will not be effective unless it is given in writing and is signed, in which case it will be effective in the specific instance and for the specific purpose given.

## 15. ASSIGNMENT

You may not assign or delegate any right or obligation under these Terms without prior the consent of Stradigi AI.

## 16. MODIFICATION

The Website is a dynamic and evolving environment subject to change.
